BE IT RESOLVED that the Town Board hereby adopts Local Law #1 for the Year 1997, entitled North Collins Telecommunications Facilities Law, and

FURTHER RESOLVED the Town Board adopts the following fee schedule for Telecommunications facilities: Item 1: Tower Special Permit: \$5,000 application fee (includes site plan fee), plus any additional costs for outside consultants incurred by the Town for review of propagation studies, search ring and analysis, co-location possibilities, or any other review deemed necessary by Town officials, and Item 2: Building Permit Fee: \$250 base fee (examination of plans and review), plus \$10 per thousand dollar value of total verified construction cost.

Additional Antenna or Any Associated Equipment on Existing Tower: \$500.00

Wind Energy Conversion System – Small Scale: \$1000.00

Wind Energy Conversion System – Large Scale: \$2500.00

Special Use Permit: \$200.00

Apply at Town Clerks Office – Brought to Town Board who directs the Planning Board to meet – Planning Board meets - Reports and Recommends back to the Town Board who sets a Public Hearing and votes on the permit. (Article XIII 185-47 to 185-49: Special Use Permits)

Site Plan Review: \$250.00

Apply at Town Clerks Office – Brought to Town Board who directs the Planning Board to meet – Planning Board meets - Reports and Recommends back to the Town Board who votes on the permit. A Public Hearing can be set if the Planning Board feels that there is a need.

(Chapter 157: Site Plan Review)

Zoning Board of Appeals (Variance): \$150.00

Apply at Town Clerks Office – Clerk notifies the Zoning Board of Appeals who sets a meeting date – ZBA meets and makes their decision. (Article XII 185-44 to 185-46: Board of Appeals)

Building Without a Permit: \$250.00 + Permit Fee + Ticket for Court
