Item 1. Supervisor Seege called the meeting to order and led the Pledge to the Flag.

Item 2. Supervisor Seege introduced Erie County Comptroller Stefan I. Mychajliw, who presented his Annual financial report for the County, and explained his program for electronic banking, cashback, and efficiencies. He suggested that Harvard's Kennedy School of Government offers classes that are tremendously helpful.

Item 3. James Lint gave a presentation on the proposed **Veterans' memorial**, and showed samples of the bricks which may be purchased for the proposed park walkway. He is looking for members of his committee.

DEPARTMENTAL REPORTS

Item 4. **HIGHWAY SUPERINTENDENT**. Mr. Winter reported that all his department's equipment is ready for the winter season. He would like to be consulted prior to adoption of the new budget.

Item 5. **CODE ENFORCEMENT OFFICER**. Mr. Tremblay inquired about

- 1) How much land needs to be included in the site for the Jennings Road cell tower, and was told that there needs to be two acres.
- 2) The Planning Board has not been given the information regarding Gary Toner's request for expansion of his use of his auto garage. Mr. Tobia is working with Chairman Michael Drumm. The Town Clerk would like to have notice of Planning Board meetings for posting on the website and the bulletin board.
- 3) Re the Marshfield Cemetery access, the neighboring property owner has removed the blocking log, but would like the Town to erect a sign indicating where visitors should park. Mr. Winter and Mr. Tremblay will work on this.

Item 6. **PARKS COMMITTEE**. Susan Alessi and Mr. Winter reported that a well had been dug in New Oregon Park and will be connected soon. High School Student volunteers have been working on the flower beds. The Parks Committee would like water access at the Senior Center parking lot for next year's Community Garden.

Item 7. **LIBRARY** Board President Susan Alessi reported on the "Celebrate North Collins" event and thanked all who donated and volunteered.

Item 8. **RECREATION** Director Jan Mathis presented a list of current and future programs. The North Collins Athletic Association needs a place to store soccer nets.

Item 9. **THE TOWN BOARD HELD A PUBLIC HEARING ON LOCAL LAW #1, 2014, a Law to Allow of the Town of North Collins to adopt a budget for the year 2015 that would override the tax levy limit as defined by general Municipal Law 3-c**
