THE REGULAR MONTHLY MEETING OF THE TOWN BOARD OF THE TOWN OF NORTH COLLINS WAS HELD ON WEDNESDAY, APRIL 8, 2015, AT 7:00PM IN THE NORTH COLLINS TOWN HALL, 10569 MAIN STREET, NORTH COLLINS, NEW YORK.

Item 1. Supervisor Seege called the meeting to order and led the Pledge to the Flag.

Item 2. Mrs. Seege introduced Erie County Legislator Chair John Mills, who presented a certificate of achievement to Elizabeth Novoa, for her election as Student Representative.

Mr. Mills also spoke about road funding, new road equipment, and a new pawn shop law. Traffic signs have been erected at Quaker and Marshfield Roads.

Item 3. Kathleen Mecca presented a proposal from **Ambit Company**, for reduction in electric costs. She would also like to review the Town's insurance policies.

Item 4. Mr. Tobia introduced Jill Sawyer and Edward Schiller, from KHEOPS, formerly TGVA Engineering, who would like to be considered as **grant writers** for the Town. They would charge a flat monthly retainer of \$1500. Extra engineering studies would cost an additional \$95 per hour. Mr. Tobia would like to have the Village share costs. Mr. Schaus suggested that Mr. Tobia and Mrs. Seege meet with Mayor George about this.

Item 5. Mrs. Seege moved:

BE IT RESOLVED THAT THE TOWN BOARD ENTER INTO A PUBLIC HEARING at 7:30 PM ON PROPOSED LOCAL LAW #1 FOR 2015, ENTITLED: A LOCAL LAW TO AMEND THE NORTH COLLINS TOWN CODE TO MAKE REVISIONS TO THE EXISTING TOWN LAW GOVERNING WIND ENERGY CONVERSION SYSTEM ("WECS")

Second: Perry.

ROLL CALL: Ayes: Mathis, Perry, Ricotta, Seege, Tobia. Noes 0. Motion carried.

Attorney Schaus explained that there are two parts to the proposed law- one for commercial windmills and one for small energy projects. The changes specifically add Section J, which pertains to Agricultural use. Mr. Schaus also recommends allowing an increase in permitted height from 150 to 155 feet. Any higher height windmills must be submitted to the Planning Board for approval. The new changes also allow "remote net metering" and filing of the short form SQR.

Planning Board chair Michael Drumm explained that the Planning Board intended to make the law more open to current trends.

Padma Kasthurirangan of Niagara Wind Energy explained that Travis Winter's windmill would be a total of 159 feet, and that the generated power would be used by Mr. Winter only on his own properties.

Donald Partridge of the Batavia Planning Board spoke in favor of the new law.

Mr. Schaus explained that the old law required height variances obtained from the ZBA, while the new law allows the heights to be recommended by the Planning Board and approved by the Town Board.

Michael Stefan of Jennings Road spoke in favor of the new law, stating that he intends to apply for a windmill for his farm and hay business operations.

Mr. Drum wanted the payment in lieu of taxes (PILOT) provision (Section III) removed, but Mr. Schaus recommended that it remain, as the prerogative of the Town Board. Any PILOT program participant would require Erie County IDA approval.

Mrs. Seege moved:

BE IT RESOLVED that all interested persons having been heard for or against such law, that the Public Hearing be closed at 8:05PM. Second: Tobia.

ROLL CALL: Ayes: Mathis, Perry, Ricotta, Seege, Tobia. Noes 0. Motion carried.

Item 6. Mr. Tobia moved: BE IT RESOLVED THAT

WHEREAS, a Public Hearing was duly held by the North Collins Town Board on April 8, 2015 at 7:30PM at the North Collins Town Hall in order to hear all interested parties on the subject of proposed Local Law #1 of the year 2015 entitled "A Local Law to Amend the North Collins Town code to Make Revisions to the Existing Town Law governing Wind Energy Conversion Systems ("WECS"), and

WHEREAS, notice of said public hearing was duly published in the *Hamburg Sun*, the official newspaper of the Town, and proof of publication is maintained in the Town Clerk's Office, and

WHEREAS, the Public Hearing was duly held as scheduled and all parties in attendance were permitted an opportunity to speak in favor of or in opposition to said proposed local law, or any part thereof, and

WHEREAS, pursuant to Part 617 of the implementing regulations pertaining to Article 8 of the Environmental Conservation law (State Environmental Quality Review Act – SEQR) it has been determined by the Town Board of the Town of North Collins that adoption of said proposed Local Law will not have a significant adverse effect upon the environment; and

WHEREAS, Municipal Home Rule Law of the State of New York provides for the adoption and enactment of local laws; and

WHEREAS, the purpose of Local Law #1 of 2015 is to amend the existing WECS law as recommended by the North Collins Planning Board and to continue to recognize that wind energy is an important alternative and clean source of energy and to allow and encourage the development and reasonable implementation of wind energy resources, while also protecting the physical and environmental health, safety and welfare of the residents of the Town of North Collins;

NOW, THEREFORE IT IS HEREBY

RESOLVED, that the Town Board of the Town of North Collins hereby adopts said Local Law as Local law No. 1 of 2015 and the Town Clerk be and she is hereby directed to enter the adoption of said Local Law into the minutes of this meeting and in the Local Law Book of the Town of North Collins and to give due notice of the adoption of said local law to the Secretary of State as required by law; and it is further

RESOLVED, that the Town Board finds and declares that the amendments to the law are minor in nature and scope and are recommended by the Town Planning Board in order to continue to recognize and encourage the use of wind energy as an important alternative energy source and that the proposed changes to the WECS law will not have a significant effect upon the environment and thereby this Board finds and adopts a "Negative Declaration" under the applicable provisions of the New York SEQR law.

The question of the adoption of the foregoing resolution was duly put to a vote on roll call which resulted as follows:

#### Item 7. Mr. Tobia moved:

WHEREAS, the Town Board of the Town of North Collins (hereinafter "Town Board") has before it an Application dated January 14, 2013, submitted by T.J. Winter and companion application of Michael J. Stefan, dated June 24, 2014, (the "Applicant"), which application seeks all necessary approvals to construct a 100KW wind turbine at 3249 Langford Road, North Collins, NY and designated on the tax roll as SBL #287.00-0-0 (the "Project") and

WHEREAS, a public hearing was held by the Town Board on April 8, 2015 at 7:30PM and the Town Board has had time to deliberate and review the application; and

WHEREAS, the Town Board reviewed and considered the Environmental Assessment Form submitted by Applicant and the Town Board desires to make the required findings under the State Environmental Quality Review Act (SEQRA");

NOW THEREFORE, upon consideration by this Board of all submissions contained in the Application and upon the completion of a public hearing on and having given this matter careful consideration the Town Board makes the following findings:

1. The Town Board has reviewed the Environmental Assessment Form completed by Applicant and reviewed by the Code Enforcement Officer. This Application was then

reviewed at several prior public meetings held by the Town Planning Board culminating on September 26, 2014, when the Planning Board recommended approval of the Application.

- 2. The town Board held a public hearing on the application on April 8, 2015.
- 3. The Town Board finds that only one wind turbine is being proposed and only one wind turbine should be constructed.
- 4. The Project will not create any adverse change in the existing air or water quality, nor are any adverse changes foreseen regarding erosion or drainage problems. The Project will produce minimal disturbance of soil and vegetation upon the affected land during construction. The Project will not adversely affect agricultural, archeological, historical, natural or cultural resources. The Project will have no impact upon plant or animal life.
- 5. It is noted that pursuant to the Town's applicable law, the Town Planning Board has recommended the issuance of the requested Wind Energy Permit.
- 6. The Project will not have any significant adverse long term, short term, cumulative or other environmental effects and will not have an impact upon the public health.
- 7. The Board notes that 6 NYCRR ~617.1 states it is the intention of the SEQR regulations that a suitable balance of social, economic and environmental factors be incorporated in the planning and decision making of local agencies and that it is not the intention of SEQR that environmental factors be the sole consideration in decision making.
- 8. The Board notes that the New York State Department of Agriculture and Markets (NYSDA&M) has recognized that an increasing number of farm operators are installing small scale wind turbines as production facilities to help offset farm production costs. NYSDA&M encourages the use of wind turbines in the development and improvement of agricultural lands for the production of agricultural products as recognized by the New York State Constitution Article XIV, Section 4.
- 9. The Applicant's land is located within a New York State certified Agricultural District and is zoned R-A.
- 10. The Board has considered all the evidence submitted and has determined that the Project will not have a significant adverse environmental effect upon the community. The Board finds that this Project is an "Unlisted Action" under SEQR and hereby issues a **Negative Declaration** for the Project. Second: Seege.
- ROLL CALL: Ayes: Mathis, Perry, Ricotta, Seege, Tobia. Noes 0. Motion carried.

#### Item 8. Mr. Tobia moved:

WHEREAS, the Town Board of the Town of North Collins (hereinafter "Town Board") has before it an application dated January 14, 2013, submitted by T.J. Winter, and also a companion application signed by the land owner Michael J. Stefan, dated June 24, 2014, (collectively the "Applicant") both seeking a permit allowing Mr. Winter to construct a 100KW wind turbine at 3249 Langford Road (Rte 249) north Collins, NY and designated on the tax roll as SBL #287.00-1-1, and

WHEREAS, North Collins Town Law, and in particular Local Law #1 of 2015 ("Wind Energy Conversion Systems") permits the Town Board to issue a Wind Energy Permit subject to the provisions therein; and

WHEREAS, the above referenced application was previously referred to the Town Planning Board for a site plan review and report and recommendation thereon to the Town Board; and

WHEREAS, the Planning Board has submitted copies of their minutes dated September 26, 2014, approving the Application but conditioned upon certain changes being made to the Town Law; and

WHEREAS, a Public hearing was held by the Town Board on April 8, 2015 at 7:30PM and the Town Board has had time to deliberate and review the application; and

WHEREAS, the Town Board has reviewed and considered the Short Form Environmental Assessment Form submitted by Applicant and the Town Board has completed its review under the State Environmental Quality Review Act ("SEQRA");

NOW THEREFORE, upon consideration by this Board of all written and oral submissions in the Application and upon the completion of a public hearing on the application and having made certain revisions to the Town Law and having given this matter careful consideration, this Board makes the following findings:

- 1. The Town has in place a law governing Wind Energy Conversion Systems (WECS) or the type proposed by Applicant.
- 2. The New York State Department of Agriculture & Markets (NYSDA&M) has recognized that an increasing number of farm operators are installing small scale WECS as production facilities to help offset farm production costs. The NYSDA&M considers wind turbines to be on-farm buildings and encourages the use of wind turbines in the development

and improvement of agricultural lands for the production of agricultural products as recognized by the New York State Constitution, Article XIV, Section 4.

- 3. The Applicant's land is located within a New York State certified Agricultural District and is zoned R-A.
- 4. The project consists of a proposed wind energy turbine to be constructed at 3249 Langford Road (Rte 249) North Collins, NY on land owned by Mr. Stefan and leased to Mr. Winter. The proposed wind turbine is a 100KW wind turbine with 78' rotor diameter on a 120' self-supporting Monopole Tower with an overall height of 159' (blade tip measured from the foundations).
- 5. The site is zoned Agricultural and is presently used as a farm. The applicant owns approximately 100 acres of land (SBL 287.00-1-1) upon which the proposed wind turbine will be located.
- 6. As indicated in the application, the proposed turbine will be a Northern Power Systems 100-24 turbine.
- 7. The applicant has submitted all required and requested documentation and has conferred with the North Collins Planning Board.
- 8. The North Collins Planning Board recommended approval of the Wind Energy Permit on or about September 26, 2014, conditioned upon various revisions being made to the town law governing WECS.
- 9. That on April 8, 2015, the Town Board duly adopted the recommended amendments to the Town's WECS law.

NOW, THEREFORE BE IT RESOLVED, that the Town Board hereby grants to the applicant a Wind Energy Permit to construct a 100KW wind turbine at 3249 Langford Road, Jennings Road, North Collins, New York in accordance with the terms of the application and in accordance with the terms and provisions of the Town Planning Board's recommendations and the proposed Wind Energy Use Permit, said Permit to be drafted and issued by the Town Clerk. Second: Perry.

ROLL CALL: Ayes: Mathis, Perry, Ricotta, Seege, Tobia. Noes 0. Motion carried. Mr. Schaus and the Town Clerk will draft permit forms.

Item 11. **CODE ENFORCEMENT OFFICER**. Mr. Tremblay has received a rezoning application for a Route 62 property, adjacent to the Blidy Property. Mrs. Seege moved: BE IT RSOLVED that the rezoning application of Ray Hammer for property on Route 62 to be rezoned from R-C to C-2 be referred to the Planning Board, and

FURTHER RESOLVED that the Town Board sets a Public Hearing for May 13, at 7:30PM to this approval. Second: Ricotta.
