Supervisor John Tobia thanked all 4 companies that bid on the Lawtons Water Project and stated we have very competitive bid process. The four companies that submitted bids, ranged from a low bid of \$385,900 to a high bid of \$547,105.

This Contract was put out to bid on March 20th, 2020. The bids were opened on Friday April 17th, 2020. MDA Consulting has reviewed all of the bids and has made a recommendation to the town how to proceed. The four bids submitted were as follows:

1. Kandey Company, INC \$385,900
2. NFP & Sons, INC \$391,805
3. Pinto Construction Services \$484,956
4. JD Northrup Construction \$547,105

Our engineer has submitted a bid opening Summary and Bid Tabulations for all the bids which will be turned over to the Town Clerk. All bids have been reviewed for price, completeness and accuracy. Based upon our engineers' recommendation, I would like to introduce the following town board resolution, awarding the construction contract to the low bidder Kandey Company INC.
